RE: COVID-19 Section 8 HCV Waivers and Program Changes

This letter is to explain some temporary changes to the Housing Choice Voucher (HCV) Program to protect owners, participants and Hudson Housing Authority staff. First, the HHA will be providing service in a manner to limit in person contact. Where possible, services will be performed by mail, email, telephone and fax. The Hudson Housing Authority (HHA) has amended our policies to accept electronic signatures and scanned documents where permissible to the Department of Housing and Urban Development (HUD). Below are some additional changes authorized by HUD. Please note all of the dates below are established by HUD. They may change if HUD extends them.

Rental Payments

We have procedures in place to ensure families with decreases in income can have their rent share decreased quickly. Where applicable the HHA will make these changes retroactive. While we are working remotely at this time we do not anticipate and delay in the HHAs payments to owners.

Inspections for New HCV Families

If a tenant was allowed to move into a unit with minor non-life threatening violations after an inspection the HA may be provide you with an additional 30 days (total of 60 days) to make the repairs. These additional extensions may be issued until July 31,2020 but the timeframe for repairs may extend beyond that date.

Inspections for Existing HCV Tenants

Until July 31, 2020, if a family or government official informs the HHA that the unit does not comply with the Housing Quality Standards, the HHA may have the owner make repairs and certify as to the condition of the unit.

If you had an biennial or interim inspection which failed due to a non-life threatening deficiency, you may certify to the HA that you have made the repair or the HA may accept receipt from a vendor, a photo of the repair or tenant confirmation that required repairs are complete. This is at the discretion of the HHA and the HA will provide you with the certification form if this provision applies.

If the biennial inspection of your unit is due this year, it may be delayed. It is expected that it will be performed before October 31, 2020.

Contract Terminations

If your assisted family pays the full amount of rent your housing assistance payments contract would ordinarily expire after 180 days, if the reason the family is paying the full rent is COVID-related the HHA may be able to extend HAP contract beyond the 180 days until December 31, 2020. Families have been advised to contact the HHA if this is the case.
